The name of the Corporation is Jim M. Malone Inc.

The Corporation shall begin its existence upon the date of filing with the Division of corporations.

ARTICLE THREE

The purpose for which the Corporation is organized is the transaction of any or all lawful business for which Corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The total number of shares of stock which the Corporation shall have authority to issue is FIVE HUNDRED (500) all of one class, namely common stock, and the par value of each share is ONE (\$1.00) Dollar amounting in the aggregate to FIVE HUNDRED (\$500) Dollars.

ARTICLE FIVE

The Corporation will not commence business until it has received for the issuance of shares consideration of the value of \$1.00 consisting of money, labor done or property actually received. ARTICLE SIX
