ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of a professional corporation to be formed under Chapters 607 and 621 of the Statutes of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

The name of the professional corporation (the "Professional Corporation") is DAVID L. WOLFE, P.A., whose principal office shall be located at 28000 Spanish Wells Blvd., Suite 220, Bonita Springs, Lee County, Florida 34135.

ARTICLE II

The sole and specific purpose for which the Professional Corporation is organized is to engage in providing legal services to the public, as attorneys at law, only through shareholders and individuals who are themselves duly licensed and authorized to render the professional services of attorneys at law.

ARTICLE III

The aggregate number of shares which the Professional Corporation shall have authority to issue is One Thousand (1,000) shares of common stock, and the par value of each such share is One and No/100 Dollar (\$1.00) per share, amounting in the aggregate to One Thousand and No/100 Dollars (\$1,000.00). Only those persons who are duly licensed to practice law in the State of Florida may become, and be owners of the shares of stock of the Professional Corporation.

ARTICLE IV

The street address of the initial registered office of the Professional Corporation is 28000 Spanish Wells Blvd., Suite 220, Bonita Springs, Florida 34135, and the name of its initial registered agent at such address is David L. Wolfe.

ARTICLE V

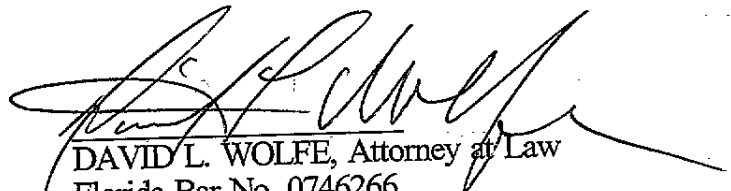
