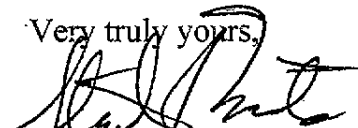

**ARTICLES OF INCORPORATION OF

The undersigned, acting as a subscriber of a corporation under the Florida General Corporations Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I--NAME AND ADDRESS

The name of the corporation shall be Investigative Field Services II, Inc., 330 Biscayne Blvd., Suite 625, Miami, FL 33132.

ARTICLE II--PURPOSE

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE III--DURATION

The corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE V--INITIAL BOARD OF DIRECTORS

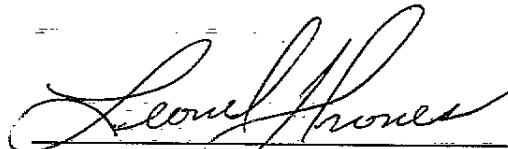

The name and address of the person signing these Articles is Leonel Jhones, 330 Biscayne Blvd., Suite 625, Miami FL 33132.

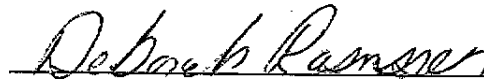

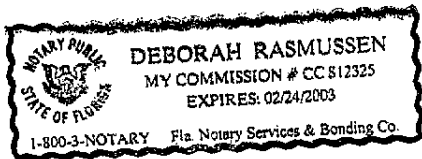

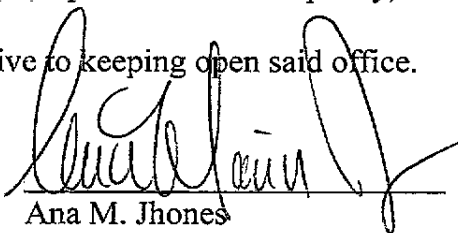
ACCEPTANCE OF DESIGNATION OF REGISTERED AGENT
