ARTICLES OF INCORPORATION  
OF  
E-Z COCHE, INC.

The undersigned herewith form a Corporation within the Laws of the State of Florida, by and under the provisions of the State Statute providing for the formation, privileges rights, liabilities and immunity of a Corporation.

ARTICLE I

The name of this Corporation shall be:

E-Z Coche, Inc.

ARTICLE II

The Corporation may engage in any business activity permitted under the laws of the United States and the State of Florida.

ARTICLE III

The amount of Capital Stock authorized shall be 100 Shares of common stock with a par value of \$100.00 per share. Said stock shall be nonassessable, to be held, sold and paid at such time and in such manner as the Board of Directors may determine.


The Incorporator shall hold office as the Director of the Corporation until a successor shall be elected or appointed, at which time the Incorporator shall resign.




