ARTICLE I - NAME

The name of this corporation is OFFICE RADIO NETWORK.com, INC., (hereinafter "Corporation").

ARTICLE II - DURATION

This Corporation shall exist perpetually, commencing on the date of filing of these Articles of Incorporation.

ARTICLE III - PURPOSE

This Corporation is organized for the following purposes: To engage in all facets of the internet radio broadcasting business, and to do all or anything connected therewith or incidental thereto in connection with the foregoing, and for the purpose of transacting any or all lawful businesses of any kind or description permitted by law.


**ARTICLE X - INDEMNIFICATION**


