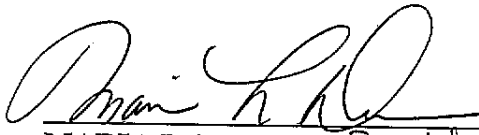

FOURTH: The sole share holder of the corporation was **MARIA L. DRUMM** and she authorized the dissolution.

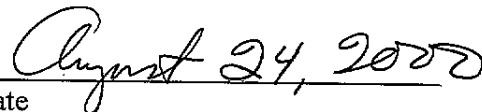
FIFTH: The winding up of the Corporation pursuant to the dissolution was anticipated to go until **AUGUST 1ST, 2000**.
