**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is THREE BROTHERS ENTERPRISES, INC., and the principal address and principal place of business is 1500 McMullen Booth Road, A-11, Clearwater, Florida 33759.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is c/o STEVEN W. MOORE, P.A., 2240 Belleair Road, Suite 100, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Steven W. Moore.

**ARTICLE III - PURPOSE**


