



#### ARTICLE I. Name and Initial Address

The name of this corporation is FIVE YUPPIE INVESTORS, INC. and initial address of the corporation is 3733 Tamiami Trail North, Naples, Florida 34103.

#### ARTICLE II. Duration

This corporation shall exist perpetually commencing on the date of execution and acknowledgment of these articles.
