**Name**

**ARTICLE II**  
**Duration**

This corporation shall have perpetual existence.

**Purpose**

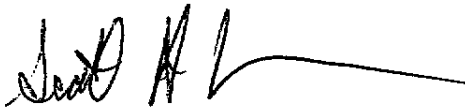

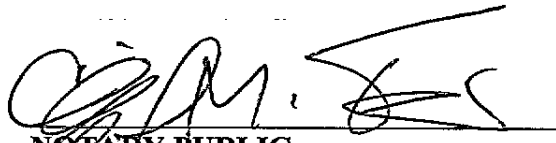

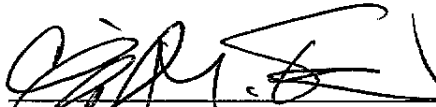
