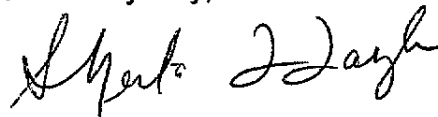

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation is: SANTA ROSA PLUMBING COMPANY, INC.

ARTICLE II

The term of existence of the corporation is perpetual and the effective date of this corporation is January 1, 2000.

ARTICLE III

The purpose of this corporation is to install and repair residential and commercial plumbing and all other legal activity.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price of which it is offered to others.

ARTICLE VI - INITIAL REGISTERED
