ARTICLE I

The name of this corporation is: **A+ SIGN STATION, INC.**

ARTICLE II

The effective date of this corporation shall be January 1, 2000.

ARTICLE III

The term of existence of the corporation is perpetual.

The purpose of this corporation is to manufacture and sell signs and any and all other lawful business.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.
