ARTICLES OF INCORPORATION FOR MARTINEZ HARVESTING, INC.

The undersigned subscriber to these Articles of Incorporation does hereby form a corporation under the laws of the State of Florida.

ARTICLE 1

The name of this corporation shall be MARTINEZ HARVESTING, INC., The street address of said corporation is 2625 North Brook Road, Ft. Meade, Florida 33841 and the mailing address is P. O. Box 644, Bartow, Florida 33831.

ARTICLE 2

In pursuance and not in limitation of the general powers conferred by the laws of the State of Florida, it is expressly provided that this corporation shall engage in any activities or business permitted under the laws of the State of Florida and the United States.

ARTICLE 3

The capital stock of this corporation shall consist of one thousand (1,000) shares of common stock of one dollar and no/100 (\$1.00) par value.

The whole or any part of the authorized capital stock may be paid for in cash, real, or personal property, mortgage or services at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.

ARTICLE 4

The street address of the corporation's initial registered office is 2625 North Brook Road, Ft. Meade, Florida 33841, and the name of its initial registered agent at such address is RUTH MARTINEZ.

ARTICLE 5

This corporation shall have three (3) directors initially. The number of directors may be increased from time to time by the by-laws adopted by the stockholders, but shall never be less than one.

The period of existence of this corporation shall be perpetual or until dissolved by law.


