This address is the same as the principal place of business and the mailing address of the corporation.

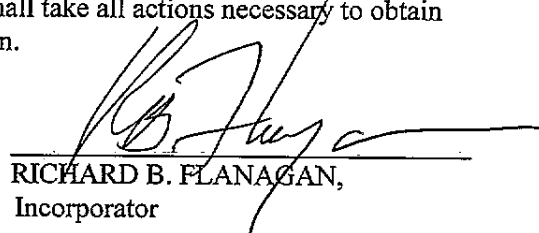
6. The initial Board of Directors shall have 2 members whose name's and address are as follows:

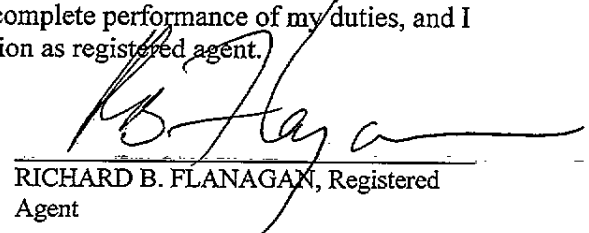
