## ARTICLES OF INCORPORATION

OF

# ARTICLE I -- NAME

The name of this corporation is CREASEGEAR, INCO The principle place of business and the mailing address of this corporation shall be 8404 N.W. 17th Court, Pembroke Pines, Florida, 33024-3406.

# ARTICLE II -- DURATION
