## ARTICLES OF INCORPORATION

OF

## MILLENNIUM GAMES & VENDING, INC.



## ARTICLE I

The name of this corporation shall be MILLENNIUM GAMES & VENDING, INC., and the principal place of business will be 1432 Cypress Drive, Unit 5, Jupiter, FL 33469.

# ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

# ARTICLE III

The maximum number of shares of capital stock which the corporation is authorized to have at any time is One Thousand (1,000) shares of common stock, \$1.00 par value.

#### ARTICLE IV...

The corporation shall have perpetual existence.

## ARTICLE V ---
