To Whomever it May Concern,

I have enclosed the 2000 Uniform Business Report for Prestige Custom Cleaning Service, Inc. and original \$150 filing fee. I request a waiver of additional fees due to the following circumstances.

In late 1999 I contacted Barry Engel, CPA to complete the 1999 income tax for Prestige Custom Cleaning Service, Inc. and file papers to incorporate. It was not until June 2000 that I received any indication from the IRS that the application for incorporation was even received. I enclose as proof copies of payroll tax submissions until July 2000 from myself and my new accountant, John E. Russi, CPA, P.A. with no EIN. Numerous phone calls to Mr. Engel were met with the response that he had no recollection of even filing the papers. Mr. Russi was finally able to refile incorporation papers and in June I received notification from the IRS that Prestige Custom Cleaning Service, Inc. had been incorporated. I am uncertain of the date of incorporation but I believe it was May or June 2000. To date, I have made eight separate phone calls to Mr. Engel's office requesting return of income tax and incorporation paperwork and have received nothing!

I am unclear how I could have filed a Uniform Business Report for Prestige Custom Cleaning Service, Inc. until well after May 1, 2000 with no certainty that the company had been incorporated. Indeed, most recent information indicates the company was incorporated after May 1, 2000.
