

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

## ARTICLE ONE - NAME AND ADDRESS

The name of the corporation shall be **Cruz Bail Bond Services, Inc.** The principal place of business of this corporation shall be **3181 South Military Trail, Suite #1, Lake Worth, FL 33463.**

## ARTICLE TWO - DURATION

The term of the corporation's existence is perpetual effective January 1, 2000.

## ARTICLE THREE - PURPOSE

The corporation's purpose is to engage in and to transact any and all business for which corporations may be incorporated under the Florida General Corporation Act.

## ARTICLE FOUR - CAPITAL STOCK




