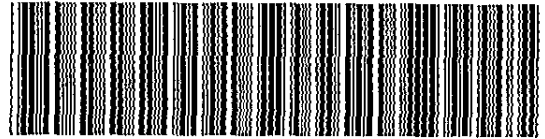



**Corina C. Radney, P.A.**


**SECOND:** The general nature of the business to be transacted by this corporation will include engaging in services and activities associated with Real Estate.
