**ARTICLES OF INCORPORATION  
OF  
BARRY CHEESMAN GOLF, INC.**

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME AND ADDRESS:** The name of the Corporation is **BARRY CHEESMAN GOLF, INC.** and its mailing address is 2901 Theresa Lane, Sarasota, Florida 34239.

**ARTICLE II**

**DURATION:** The Corporation shall exist perpetually.

**ARTICLE III**

**PURPOSE:** The Corporation is organized for the purposes of providing professional golf services and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

#### ARTICLE IX


**INDEMNIFICATION:** The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

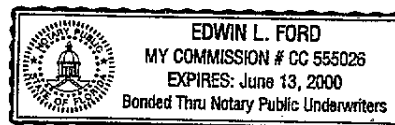


