
For year 2002 there were no changes in the name or address from the prior year and the UBR was timely filed as you can note by the copy attached. Your office rejected the UBR and issued a notice dated June 18, 2002 which according to your office was correctly addressed to 100 N. Biscayne Blvd., 21st. FL but still failed to reach the undersigned at all and in fact it was only this week she learned by a chance internet search that the company was inactive at this point.

Please note I'm enclosing the fee for year 2003 for \$150.00 from her own resources and respectfully request that you waive the penalty for reinstating the corporation since the report was timely filed and in fact the undersigned did all she thought was necessary then to comply.
