The undersigned, acting as the Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is **RESCOM MANAGEMENT, INC.**

ARTICLE II

The period of duration of the corporation is perpetual; however, these Articles shall have a delayed effective date, and the corporation shall be deemed to begin, on January 1, 2000.

ARTICLE III

The purposes for which the corporation is organized are to providing management services and in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV

Authorized shares

Number:

The aggregate number of shares that the corporation shall have the authority to issue is 1000 shares of Class A Common Stock.

Voting Rights:

Each share of Class A Common Stock will entitle the holder to 1 vote per share.

Par Value:

Each share shall have a stated par value of \$1.00.

ARTICLE V

The holders of the Common Stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, such of the shares of this stock of this corporation as may be issued for any reason. The preemptive right of any holder is determined by the ratio of authorized and issued shares of Common Stock owned by the shareholder to all shares of Common Stock currently authorized and outstanding.


