The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

1. The name of the corporation is: **BOZAN CONSTRUCTION INC.**

7. The incorporator of this corporation is Bohumil Novak whose address is 1304 Four Seasons Blvd., Tampa, FL 33613


