ARTICLE I NAME

The name of the corporation shall be PAUL LANDRY, P.A.

ARTICLE II PURPOSE

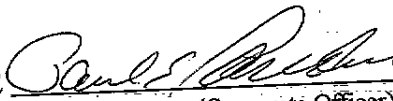

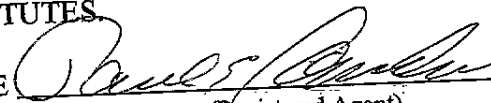
