ARTICLE V. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

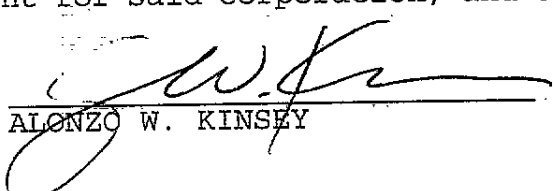

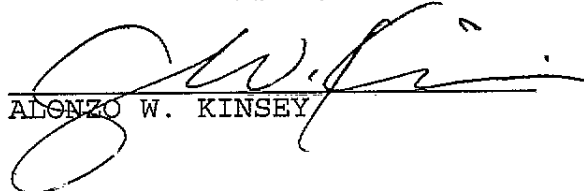
