I, the undersigned subscriber, hereby come before the state of Florida for the purpose of becoming a corporation. This corporation is organized by and under the provisions of For-Profit Corporation's statutes of the State of Florida.

ARTICLE I

NAME and OFFICE ADDRESS

ARTICLE II

GENERAL NATURE OF BUSINESS

This corporation may engage in all forms of consulting for formal gatherings to include weddings, banquets, corporate annual meetings, picnics, and other events. The corporation will also sponsor entertainment and sports promotions. The corporation will sell any product used in the rendering of consulting and promotion services. The corporation may also conduct any other activities or businesses permitted under the laws of the state of Florida.
