#### ARTICLES OF INCORPORATION OF **EOW ENTERPRISES, INC.**

ARTICLE 1 - NAME

The name of this corporation is EOW Enterprises, Inc.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE


