1. The name of this corporation is: KADEN INVESTMENTS, INC.
2. The duration of the corporation shall be : perpetual
3. The purpose for which this corporation is organized is to transact any and all business for which corporations may be incorporated and organized under Business Corporation Act of the State of Florida; laws of the United States of America, to open and operate a service business in Southwest Florida.
4. The corporation shall have the authority to issue initially the following shares of stock: 1000 shares of common stock, one class only with No Par Value.
