This letter accompanies the Application for Reinstatement of Kaden Investments, Inc.

I represent Mr. Kaden. I prepared the original Articles of Incorporation and had placed 4310 Sands Blvd. Cape Coral, FL., 33914 on the Articles of Incorporation. How the Annual Report (UBR) ended up in Longboat Key, FL., is a mystery to me. Mr. Kaden received no notices of renewal, and therefore did not renew his corporation. To complicate matters, Mr. Kaden has been back and forth to Germany and therefore did not even consider the renewal. Had he received the annual renewal notice, I would have completed both for his signature and they would have been mailed to your office long before the May 1 deadline for both 2002 and 2003.

For the above reason, I am requesting that the Department of State accept the enclosed \$300.00 for the annual renewal for both years, and that your office waive the \$600.00 late fee. We are not trying to beat your office out of a fee that would be justified, but only to request that you understand the equities of this case and extend the waiver. You will note that this is the only time that this has occurred.
