INDEMNIFICATION



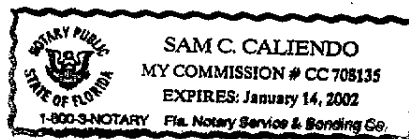


