**Article I. Name and Address**

The name of this corporation is L&K Seafood, Inc.. The address of the corporation and the principal office of this corporation is 329 Interstate Court, Sarasota, FL 34240.

**Article II. Duration**

This corporation shall exist perpetually commencing 5 days prior to the date of filing of these articles.

**Article III. Purpose**

This corporation is organized for the purpose of the wholesale sale of seafood and the purpose of transacting any or all lawful business.

**Article IV. Capital Stock**

This corporation is authorized to issue 300 shares of \$1.00 par value common stock shares of common stock without par value.

**Article V. Preemptive Rights**

Every shareholder, upon the sale for cash of any authorized and unissued stock of this corporation of the same kind, class or series as that which he already holds, shall have the right


**Article X. Indemnification**


