# ARTICLES OF INCORPORATION OF AMVEST EQUITIES I CORPORATION

# <u>ARTICLE I - NAME</u>

The name of this Corporation is Amvest Equities I Corporation.

# ARTICLE II - NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

# ARTICLE III - CAPITAL STOCK

The authorized capital of the Corporation shall be 50,000 shares of the common stock at a par value of \$1.00 per share.

# ARTICLE V - PREEMPTIVE RIGHTS
