ARTICLES OF INCORPORATION

ARTICLE I.

The name of this Corporation is:

Bob's Vending, Inc.

ARTICLE II.

This Corporation shall exist in perpetuity commencing on January 1, 2000.

ARTICLE III.

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV.
