The name of the Corporation shall be:

ARTICLES XI

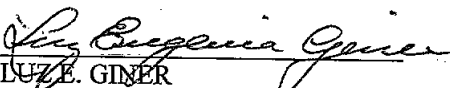
General Operation Procedures:
