#### ARTICLE I - NAME

The name of this corporation is MONARCH PROJECTS, INC. The principal address of said corporation is 1 NE First Avenue, Suite 303, Ocala, Florida 34470.

## **ARTICLE II - DURATION**

This corporation shall have perpetual existence.

#### **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

This Section is intended to expand the ability of the corporation to conduct business with interested parties and shall not be construed to invalidate any contract of other transaction that would otherwise be valid under the common and statutory law applicable to it.

# ARTICLE VIII - INITIAL REGISTERED AGENT AND OFFICE
