Article I - Name

The name of this corporation is **BARRY E. HUBBARD, P.A.** The mailing address for the corporation is 4817 NW 72nd Lane, Gainesville, FL 32653.

Article II - Duration

This corporation shall have a perpetual existence, commencing on the date of filing these articles with the Department of State.

Article III - Purpose

The professional service corporation is formed to engage in every phase and aspect of the practice of real estate broker. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

Article IV - Capital Stock

This corporation is authorized to issue ten thousand (10,000) shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

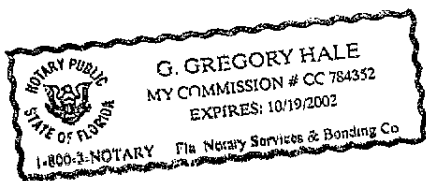
