ARTICLE I - NAME

The name of the corporation is GROWERS RISK MANAGEMENT, INC.

ARTICLE II - NATURE OF BUSINESS

The general character, purpose, and nature of business to be transacted by this corporation is to own and operate a general insurance agency, as well as any other activity or business legally permissible under the applicable laws of the State of Florida or the United States of America.
