ARTICLES OF INCORPORATION OF FREQUENCY MUSIC, INC.

The undersigned subscriber to these Articles of Incorporation, James M. Dalia, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is FREQUENCY MUSIC, INC. The principal office and mailing address of the corporation is 27821 South Tamiami Trail, Unit 1, Bonita Springs, Florid 34134.

DURATION

The Corporation shall have perpetual existence, commencing upon January 3, 2000.
