ARTICLES OF INCORPORATION

OF

BETTINA BESHERE & ASSOCIATES, P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent and licensed to practice certified public accounting in the State of Florida, acting as incorporator for the purpose of forming a professional service corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be BETTINA BESHERE & ASSOCIATES, P.A.

ARTICLE II PRINCIPAL ADDRESS

The principal place of business and mailing address of the corporation is 451 Sabal Trail Circle, Longwood, FL 32779.

ARTICLE III NATURE OF BUSINESS
