Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of Patrick's Productions, Inc., a Florida corporation (the "Corporation"), are hereby amended as follows:

1. Article III shall be amended to read as follows:

"ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue Two Thousand (2,000) shares of common stock, all of which are to have a par value of One Cent (\$.01) per share. The Board of Directors shall fix the consideration to be received for each share. Such consideration shall consist of any tangible or intangible property or benefit to the Corporation, including cash, promissory notes, services performed or written promises to perform services and shall have a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares."

2. The undersigned, hereby certifies that the foregoing Amendment to the Articles of Incorporation was duly adopted and approved by the sole director of the Corporation on September 27, 2000 and by the sole shareholder of the Corporation on September 27, 2000. The number of votes cast was sufficient for approval.
