

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BLACKSTONE E-COMMERCE, INC.

Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is **BLACKSTONE E-COMMERCE**, INC.
- 2. The following Amendment of the Articles of Incorporation was adopted by the Shareholders of the Corporation on the | day of May . 2007, in the manner prescribed by Florida law.

Article VIII of the corporate charter filed on January 5, 2000, is amended as follows:

#### "ARTICLE VIII Capital Stock

The Corporation is authorized to issue ONE HUNDRED (100) shares of ONE AND NO/100 DOLLARS (\$1.00) par value common stock which shall be designated "Class A Voting Common Shares"; and ONE HUNDRED (100) shares of ONE AND NO/100 DOLLARS (\$1.00) par value common stock which shall be designated "Class B Nonvoting Common Shares". The Class A and Class B shares shall be entitled in all respects to equal rights and privileges except that each share of Class A shall be entitled to one (1) vote and each share of Class B shall be nonvoting stock."

- 3. The number of shares of the Corporation outstanding at the adoption was six hundred (600), and the number of shares entitled to vote thereon was six hundred (600).
- 4. The number of shares voted in favor of such Amendment was six hundred (600), and the number of shares voted against such Amendment was none.
- 5. This Amendment shall become effective immediately upon tiling with the Department of State of Florida.
