The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby form a Corporation for Profit under the provisions of Section 607 of the Florida Statutes, with all powers, rights, privileges, and immunities; and to that end, sets forth by these Articles:

ARTICLE I - NAME

ARTICLE II - DURATION

This Corporation shall have perpetual existence.




ARTICLE IX - INCORPORATIONS
