

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of this Corporation is Claims Review, Inc.

The name and street address of the incorporator are Bryan L. Putnal, 10430 Hunters Creek Court, Jacksonville, Florida 32256.


#### ARTICLE VII-BYLAWS

IN WITNESS WHEREOF, the undersigned incorporator has executed these Articles of Incorporation this 3<sup>rd</sup> day of January, 2000.


