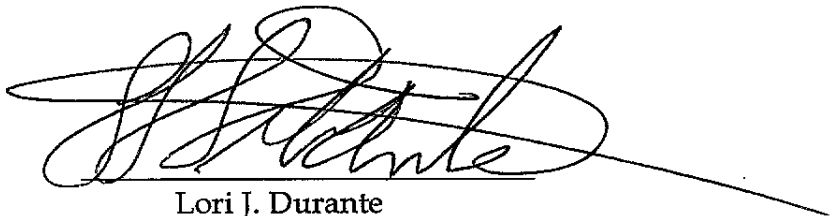
**Article XIII**
