ARTICLES OF INCORPORATION

OF

ONE WEB AVE., INC.



The undersigned, acting as (a) incorporator(s) of a corporation under the Florida General Corporation Act, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **ONE WEB AVE., INC.**.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in internet services and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporation laws or by other law, or by any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these, purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.
