The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be Collins & Collins Realty, Inc., and it shall hereinafter be referred to as "Corporation".

ARTICLE II

The principal place of business and initial mailing address of this Corporation shall be: P.O. Box 4052 Ormond Beach, FL 32175-4052.

ARTICLE III

The existence of this Corporation shall be perpetual.
