ARTICLES OF INCORPORATION OF
STEVEN M. CHAMBERLAIN, P.A.

1. Name. The name of the corporation is: STEVEN M. CHAMBERLAIN, P.A.
2. Purpose. The corporation may engage in the business of carrying on a practice of law and rendering professional legal services; provided however, the corporation may also invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and may own real or personal property necessary for the rendering of such professional services.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 100 shares of common capital stock with a par value of \$1.00 per share. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on January 1, 2000.
5. Registered Agent. The initial street address in the State of Florida of the initial registered office of the proposed corporation is 618 NE 1st Street, Gainesville, FL 32601 and the name of its initial registered agent at such address is Steven M. Chamberlain.
6. Location. The business is located at 618 NE 1st Street, Gainesville, FL 32601.
7. Management. Business of the corporation shall be managed by the stockholders.

9. Limitation. The Corporation shall not issue any of its capital stock to anyone other than an individual who is duly licensed to practice in the State of Florida to render the same professional services as those for which the Corporation was incorporated.
