The undersigned incorporator, for the purpose of forming a corporation under the Florida Corporations Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation shall be **ALPINE LEASING ASSOCIATES, INC.**

**ARTICLE II - PRINCIPAL OFFICE**

The principal office of the corporation shall be 3591 North Andrews Avenue, Suite B, Fort Lauderdale, FL 33309

**ARTICLE III - NATURE OF THE BUSINESS**

This corporation may engage or transact in any of all lawful activities permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

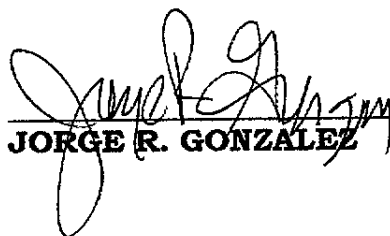
