The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is Home Improvement Professionals, Inc.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 8719 Harpers Glen Court, Jacksonville, Florida 32256.

ARTICLE II

DURATION

Section 2.1 Duration. This corporation shall exist perpetually.
