# ARTICLES OF INCORPORATION OF PEGASUS RANCH, INC.

The undersigned hereby makes and subscribes to these Articles of Incorporation intending to form a Corporation under the provisions of the Florida Statutes.

#### **ARTICLE I**

The name of this Corporation is PEGASUS RANCH, INC.

#### **ARTICLE II**

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
