OF

ARTICLE I

Name

The name of this Corporation is CRAVEN AUTO BODY, INC.

ARTICLE II

Principal Office

The principal office of this corporation shall be 9325 Craven Rd., Jacksonville, Florida 32257.

ARTICLE III

Duration

This corporation shall have perpetual existence.

ARTICLE IV

Purposes and Powers

The nature and purposes of the business to be carried on by CRAVEN AUTO BODY, INC., are to engage in the maintenance and repair of motor vehicle bodies and in any activity or business permitted under the laws of the United States and of the State of Florida.

The corporation shall have all powers of a general corporation for profit under Chapter 607, Florida Statutes, or any amendment thereto.

ARTICLE V

Capital Stock

The maximum number of shares of capital stock which this corporation is authorized to issue or to have outstanding at any one time is 1,000,000 shares of common capital stock having a par value of One Dollar (\$1.00) per share.


